## **Background**

# **Local & Foreign Bidders**

Bidders must register on the eTender Portal in order to participate in the ITB process (see Appendix 2)

- 1. Log in to portal at https://igov.etenderworld.tt
- 2. Go to Home Screen
- 3. Purchase and download Tender package

## **ITB Process**

The Invitation to Bid (ITB) will be conducted via a four (4) stage process as follows:

## Stage 1 - Review of Bid Conformance Documents:

A review of Bidders' submissions against the Bid Conformance checklist will be conducted in accordance with the requirements of the ITB. Bidders who pass this Stage 1 will therefore advance to Stage 2-Technical Evaluation.

## Stage 2 - Evaluation of Technical Specifications:

## a. Stage 2 (a) - Technical Requirements - Appendix A

Bidders are required to achieve a minimum of 70 % of the maximum score in this category in order to pass and advance to **Stage 2 (b) – Other Rated Technical Criteria**.

# b. Stage 2 (b) - Technical Requirements – Rated Technical Criteria

This category will be evaluated out of a maximum score of 100 and weighted in a 70:30 ratio between Technical and Financial respectively.

#### Stage 3 - Pre-qualification of Bidders:

Bidders will be subjected to a Pre-qualification Evaluation in accordance to the rules outlined in the Prequalification package. Only Bidders who have successfully passed Stages 1 and 2 will be evaluated at this stage. Once these Bidders are prequalified they will advance to **Stage 4 - Financial Evaluation** and their Financial submissions will be opened.

#### Stage 4 - Evaluation of Financial Submissions

The total possible score for the financial component is 30 points.
