INTRODUCING HER EXCELLENCY CHRISTINE KANGALOO PRESIDENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO

hristine Carla Kangaloo was born in San Fernando on December 1, 1961, to Carlyle and Barbara Kangaloo. She is the fifth of their seven children.

Ms. Kangaloo attended the Grant Memorial Presbyterian Primary School; St. Joseph's Convent, San Fernando; and the University of the West Indies (St. Augustine and Cave Hill Campuses). She qualified with Honours in Law from the University of the West Indies in 1983. In 1985, she obtained her Legal Education Certificate from the Hugh Wooding Law School and was admitted to the practice of law that year.

From 1985 to 1992 Ms. Kangaloo worked with her father, Carlyle, in his law practice.

In 1992, Ms. Kangaloo entered the service of the Judiciary as an Assistant Registrar of the Supreme Court. She served in that capacity for 4 years, until 1996 when, following her father's untimely passing, she returned to private practice to wrap up his practice. In 1998, Ms. Kangaloo joined an established law firm in San Fernando.

Ms. Kangaloo commenced Parliamentary service in 2001 when, in that year, she was appointed an Opposition Senator. She was appointed Vice President of the Senate between January to August 2002; a Government Senator and Minister in the Office of the Prime Minister between 2002 to 2005; Minister of Legal Affairs between 2005 to 2007; and Minister of Science, Technology and Tertiary Education between 2007 and 2010. Ms. Kangaloo was also the Member of Parliament for the Constituency of Pointe-a-Pierre between 2007 and 2010.

In 2015, Ms. Kangaloo was elected to the position of President of the Senate of the Republic of Trinidad and Tobago – a position in which she served continuously until January 2023. As President of the Senate, Ms. Kangaloo acted as President

of the Republic of Trinidad and Tobago on thirty-three (33) occasions.

Ms. Kangaloo was the first person who served as Vice President of the Senate, to become the President of the Senate. Similarly, Ms. Kangaloo is also the first person who served as President of the Senate, to become the President-Elect of the Republic of Trinidad and Tobago.

In Ms. Kangaloo's first Ministerial position, as Minister in the Office of the Prime Minister with responsibility for Social Services Delivery, Ms. Kangaloo acquired an in-depth knowledge and awareness of the needs of vulnerable, disenfranchised, marginalized disadvantaged persons, and sought to become a voice for these persons. In this Ministerial position, Ms. Kangaloo also interacted with Non-Governmental Organizations in delivering social services to these persons, and acquired in-depth knowledge of the infrastructure for the delivery of services to the public.

In Ms. Kangaloo's second Ministerial position, as Minister of Legal Affairs, she oversaw the operations of the Consumer Affairs Division which was responsible for consumer protection and advocacy,

and the heightening of awareness by consumers of their rights. As Minister of Legal Affairs, Ms. Kangaloo sought to become a voice for consumers and to provide them with information (including prices of consumer items) to enable them to make informed choices and to empower them as consumers.

In Ms. Kangaloo's third Ministerial position, as Minister of Science, Technology and Tertiary Education, she was responsible for developing and implementing training programmes for the nation's youth and others. She particularly delighted in seeing the impact of these programmes on the lives of young people.

As an elected Member of Parliament, Ms. Kangaloo assisted in addressing the everyday needs of constituents (water, public transportation, schooling, medical care, employment) and helping the, solve their problems, In this role she acquired an appreciation for the unvarnished reality of daily living of her constituents and was an advocate for their upliftment and self-articulation.

By reason of her long and varied career in multiple incarnations of public service, Ms. Kangaloo has acquired an acute, singular and comprehensive appreciation of the system and the mechanics of government and public service, and of the needs of the citizens of Trinidad and Tobago.

Ms. Kangaloo has been married for twenty-four (24) years. She is a cancer-survivor.

INAUGURAL ADDRESS BY SEVENTH PRESIDENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO

The following is an excerpt from the Inaugural address by Her Excellency Christine Kangaloo President of the Republic of Trinidad and Tobago at the Queen's Park Savannah, Port Of Spain, Trinidad and Tobago on March 20, 2023:

My Fellow Citizens...

It is March 20th 2023, and Trinidad and Tobago has just installed its Seventh President.

The ceremony by which we have done so is the result of the hard work and dedication of a large number of persons, to whom the country owes a tremendous debt this morning. And, the very first thing I should like to do, as I begin this term of the country's Seventh Presidency, is to say thank you to all the hands that have pulled together to make today's ceremony happen.

I would like to thank, especially, Her Excellency President Paula-Mae Weekes. As new Head of State, I am sure that I am constitutionally authorised to act on behalf of the entire country in thanking President Weekes for her noble and selfless service over the last five years, and I do so

unreservedly.

But, outside of constitutional entitlements, and simply as a human being, I want to thank President Weekes for the kindness and the empathy that she has shown to me, especially over the past few weeks, in helping me to prepare, not just for today's ceremony, but also for the term of office that lies before me. Madame President, you have my deepest and my sincere gratitude.

Permit me, as well, to express my gratitude to the Electoral College for having elected me to serve as the country's Seventh



Head of State. The feelings which have overwhelmed me since my election, are simply too much to put into words. All that I can do in return is to undertake to strain every muscle to vindicate the College's confidence in me, and I promise to do so.

When I was growing up, the number 7 was considered a lucky number. When teachers would hand out raffle sheets for us to take chances to raise funds for school, I would always select "7" as my number. Insofar as Presidents go, the Electoral College has selected me to be our country's number '7'. And, if, in time, history were to show my selection to have been a lucky one, let one thing be absolutely clear - that will only have been so, because of the 6 dedicated and devoted men and women who have preceded me in this office. My first request, as new Head of State, is that you therefore join me in expressing our country's collective thanks to these 6 outstanding sons and daughters.

And so, allow me, on behalf of a grateful and a beholden nation, to pay tribute today to His Excellency President Ellis Clarke – for his intellect and his courtliness. Allow

me, on your behalf, to pay tribute to His Excellency President Noor Hassanali – for his steadiness and his dignity. Allow me to pay tribute to His Excellency President Arthur Napoleon Raymond Robinson - for his pioneering and his gallantry. Allow me to pay tribute to His Excellency President George Maxwell Richards - for his erudition and his ingenuity. Allow me to pay tribute to His Excellency President Anthony Carmona - for his passionate love of country and his vitality. And allow me to pay tribute to Her Excellency President Paula-Mae Weekes - for the clearness of her convictions and for her fortitude.

By virtue of the efforts of these, our six previous Presidents, this country has written a glorious Presidential past. Today, we come together to start writing a further chapter in our Presidential history. Permit me now, to share with you a little of what I hope that future will look like.

One of the questions which invariably emerges whenever the occasion for the election of a President arises, is the role of the President in the first place. Through our collective fault, 47 years after our nation attained Republican status, significant portions of our citizenry remain unclear about precisely what the role of the President is.

During my term, I would like to continue the work begun by my predecessors in trying to demystify the role. I think that a good place to start is at the level of our primary school children.

One of our nation's founders spoke of the future of our nation being in our children's school bags; I believe that heightening awareness at the primary school level about the role of the President, will help promote a better understanding of the Presidency. I am aware of at least one primary school in South Trinidad - the San Fernando Girls Government Primary School, Standard 4 (Singh) - that has embarked on a project to heighten awareness about the role of the President. So long as that school's Principal permits, I should be very happy to meet with the students in Standard 4 (Singh) to discuss with them how they and their teachers might be able to help to lead and spread projects like theirs across the country.

This is one of the things that I hope the Presidential future that we are starting to write today, will look like. A future in which there is a population that is better informed about the Presidency, and that is therefore better able to hold it to account.

Another means through which I believe the youth – and those who interact directly with them – can come to the country's aid, particularly in this season of rising crime, is through the model provided by the steelband movement in its preparations for Panorama.

For decades, there have been those who have been telling us that the discipline and the structure that the panyard brings into the lives of young people each year in the lead up to Carnival, combine to create one of the most effective youth delinquency prevention programmes available in the country. As President, I will be anxious to meet with and listen to those voices, as I will be to use the voice of my own Office to advocate for the adoption in our communities of youth programmes based on the panyard model – not just limited to specific periods in the year, but on a year-round basis.

This is another aspect of the Presidential future I envision – a future in which

the Office of the President continues to collaborate with communities to explore, and advocate for, means by which our young people can be steered towards endeavours that are glorious and lifegiving, and away from the allure of antisocial behaviours.

As our democracy and our society mature, there is an increasing demand for our leaders to become more and more accessible. The Office of President is no exception. There are certain levels of security that attend the Office of President - including as the President moves around in public spaces and, as many of us have experienced, on the nation's roads. There are also certain protocols that guide - and often limit – how citizens interact with the President. I ask the country to understand and to bear with these arrangements: in the main, they are necessary to preserve the dignity of the Office and the safety of its occupant. But they are not immutable, and they should not be inflexible. We must be careful not to make the mistake of elevating these arrangements, into ends in themselves. And we must avoid, at all costs, conscripting them into the dubious service of making the highest office in the land, also the most remote office in the land.

I therefore undertake, during my term in office, to build on the work of my predecessors and to examine ways of modernising the protocols that govern how citizens relate with the Office, and vice versa.

One of the ways in which I would like to see the Office of President made more and more accessible, is by having its facilities put to even greater use in hosting cultural, educational and artistic ventures — particularly among the youth. For example, I would like to see the Bandstand put to regular use as a platform for new and emerging young artistes. I would like to see the main ballroom and the grounds at President's House used to host displays, such as art exhibitions by primary and secondary school students.

MESSAGE FROM THE HONOURABLE DR. KEITH ROWLEY, PRIME MINISTER ON THE OCCASION OF EMANCIPATION DAY 2023

This message on African Emancipation Day 2023 holds the sincere wishes of the Government of the Republic of Trinidad and Tobago, my own family and myself, as Prime Minister.

Some citizens may choose to see today as just another of our national holidays, greeting it as a day of relaxation and relief, but in fact, it is a momentous opportunity for us all to celebrate, and truly appreciate the uniqueness of our land.

We are multi-ethnic, multi-cultural, multi-religious -- a beautiful "patch work quilt" society, some people say. In recognising that diversity, we, as citizens, have been becoming more aware of our historical roots, and at the same time learning that our sociological make-up has forged extraordinary prospects for a workable, political consensus, if only we will let it.

We should also be reminded that this makeup has fault lines, which carry inherent dangers of entrenched cleavages and segmentation, with possibilities of ongoing contentions, and contrived, social conflicts -- which, experiences in other countries have shown -- could smoulder and ignite at any moment.

Hope, however, is one of the exceptional qualities that lodges within our collective Trinidad and Tobago personality. So today, when thousands of people of African descent take to the streets, they are asserting and glorifying their heritage, their self-realisation, grateful, too, that Trinidad and Tobago is not a torn nation, or failed state, but a real place, peopled by citizens, who every day celebrate its uniqueness, carrying their eternal hope for a better life for themselves, their families and for this nation.

In colourful attire today, we, the descendants, will be voicing to the world that we are the children, born out of the brutality of slavery, and reminding that the wrongs of that experience still echo, but we embrace hope and confidently look forward to a bright future.

We will be saying that we have been dealing with our history openly, directly, and honestly, but we cannot forget the whips on the backs of our ancestors.

The estimated figures of those who crossed the Middle Passage range from fourteen million to as high as forty million. The life of every captive meant, in varying ways, suffering and social death in a new world – first, being examined and auctioned off like an animal, then, survival on the plantation was a constant de-humanisation process — a stripping away of identity, family ties, religion, names, language, dress, culture; overall, it attempted to strip every aspect of the enslaver's humanness. Yet we survived!

Over the centuries, our ancestors endured outright murders, child separation, beatings, rape, castrations, lynchings, and mutilation, with some body parts even being severed and sold as souvenirs. Yet we survived!

Finally, the enslaved were considered not fully human, just denuded, mindless objects, who created sugar solely for foreign tables, under a Massa, as overseer, with whip and gun at hand. Yet we survived!

The gateway in Medina in the Cape Coast

province in Ghana, from which the stolen Africans departed Africa, was called "the door of no return." Yet we survived and returned to find our ancestral roots to join hands and find common causes with our modern-day brothers and sisters.

In the marches across the country today, you will see a people, coming out of the legacies of the torturous centuries of slavery, yet standing tall, proudly articulating their roots – a people saying they will not be marginalised, and are evolving in every human way.

They now see Africa, not through European eyes, as a dark continent, but as the cradle of human civilisation, citing the discoveries of its great empires. They talk of it glowingly, as the world's fastest developing economic region in the 21st century, having just overtaken Asia, and of its six of the 10 fastest growing economies in the world and of its minerals, critical and indispensable to the technologies of the 21st century green economies.

Today, recognising the pain of the Middle Passage, and the centuries of colonial brutality, I salute the African community, a people, who through grit and determination, is on the march, striving for further discovery and self-realisation, searching, and transforming themselves for the challenges of the 21st century.

Let us all reflect and educate ourselves as we celebrate African Emancipation Day 2023.

TRIBUTE TO FATHER JOHN METIVIER

is with great sadness that we announce the death of our beloved Canon John Metivier, which occurred on Monday 28th November 2022

Canon John Metivier was born in Mayaro, Trinidad and Tobago on 16 October 1931. He was educated at St. Joseph Convent State School, South Oropouche and Naparima College, San Fernando. He worked in the Petroleum Industry, the Civil Service and as an assistant teacher at Fyzabad Intermediate School.

In 1956 Canon John Metivier entered the Community of the Resurrection, Codrington College, Barbados, became Deacon in 1960 at St. Michael's Cathedral Barbados and assistant to the Rector of St James Barbados. He was ordained a priest in 1961 at the Cathedral of the Most Holy Trinity, Trinidad and became Assistant Curate at St. Crispin's. He then spent time at the Church Divinity School Canon John Metivier was one of the main

Cambridgeshire College of Arts.

In 1968, Canon Metivier became Rector of St. Mary's Parish, Tacarigua, in Trinidad and in 1977 became Rector of St. Andrew's, Tobago.

In 1978, Canon Metivier was made Priest in Charge of All Saints, Great Berkhamstead in the Diocese of St. Alban, United Kingdom. In 1982, he became Vicar of St. James, Goff's Oak, also in the St. Albans Diocese. In 1990 he became Vicar of St. Michael the Archangel, Wembley in the Diocese of London. In 1995, Canon John Metivier was appointed a Canon in Trinidad and Bishop's Commissary in the United Kingdom.

Canon John Metivier retired and in 2001 became Honorary Assistant Priest at St. Mary-the-Virgin, Kenton.

NATIONALS HONOURED AT THE HIGH COMMISSION OF TRINIDAD AND TOBAGO, LONDON

n Friday 27 January 2023, the High Commission hosted an event for staff. In addition, His Excellency Vishnu Dhanpaul, used the event to honour a number of prominent nationals who have excelled in the United Kingdom.

One such national is Baroness Floella Benjamin. Baroness Benjamin, who is the recipient of The Order of Merit, which recognizes distinguished service in the armed forces, science, art, literature, and the promotion of culture. The Order of Merit, presented to Baroness Benjamin by His Majesty King Charles III, is restricted to a maximum of 24 living recipients from the Commonwealth, plus a limited number of honorary members.

Baroness Benjamin also celebrated 52 years in Children's television and is still appearing on Children's television across the world. She is best known for the iconic children's programmes Playschool and Play Away. In 2006 Baroness Benjamin was appointed the first black woman Chancellor of University of Exeter, a top UK University. She is perhaps the only

woman in the UK to have been not only an actress in TV and film drama, a children's presenter, writer, author, independent producer, but a regulator and a policy maker in government as well. She started off her career in show business appearing on hit stage musicals before moving on to numerous dramas for both BBC and ITV.

As well are her stage film and television appearances, in 1987 she founded her own television production company and produced hundreds of children's programmes for all the major broadcasters. Her most recent programmes include Mirabelle's Home Movies, Mama Chuggington, Sarah Jane Adventures and is also a regular on CBeebies Bedtime Stories. She has written over 30 books including 'Coming to England'- which tells the Windrush story. The latest picture book edition of 'Coming to England' is now a number one best seller. The BBC film adaptation of the book won an RTS Award in 2004. She has also had experience as a regulator, she sat on the Ofcom Content Board for three years and was a member of the BBFC

Advisory Board for several years and sat on the NFTS Board for 17 years. She was Chair of BAFTA - Television and created the Children's BAFTA Awards which are now in their 20th year.

In 2010 she became the first Trinidadian woman to become a Baroness in the House of Lords where she speaks on children's, diversity and media issues. She has received numerous awards including, an OBE for her contribution to children's broadcasting, a Special Lifetime BAFTA an RTS Award, a BKSTS Fellowship, an Honorary Fellowship of the Shakespeare Birthplace Trust and the ACA-JM Barrie Award for her lasting legacy to children.

In 2020 Baroness Benjamin was made a Dame. She has just finished writing her autobiography 'What are You Doing Here?' which was published by Pan Macmillan in June 2022. She is the Chair of the Windrush Commemoration Committee which is charged with creating a National Windrush Monument. The unveiling took place at Waterloo Station on June 22 2022.

Baroness Benjamin was chosen by Her Majesty the Queen to receive the Order of Merit, one of Her Majesty's last wishes. She received the Order from King Charles III in November 2022.

Also honoured at the event was Leslie Sebastian Charles MBE, known professionally as Billy Ocean, one of the biggest recording stars with over thirty million record sales with Gold and Platinum records across the globe and a string of number ones including in the USA, Australia, Germany, Holland, and the UK.

In 2020 Billy Ocean was awarded an MBE for services to music. He also holds a Grammy award for best male R&B Vocal Performance, the Ivor Novello Award for International Achievement, two Billboard Music awards, the 2010 MOBO lifetime achievement award, and an Honorary Doctorate in music from Westminster University.

Billy Ocean's pop and soul anthems remain as popular now as they have always been. Hits such as 'Red Light Spells Danger', 'Love Really Hurts Without You', 'When The Going Gets Tough, The Tough Get Goin' and the #Grammy Award-winning 'Caribbean Queen (No More Love On The Run)' attracts millions of streams and views.

Mr. Ocean got his first break when he signed to GTO records, and a first taste of chart success with the Motownesque 'Love Really Hurts Without You', reaching number two in the UK charts and number twelve in the US.

Two top twenty singles 'Love on Delivery' and 'Stop Me...' followed before 'Red Light Spells Danger' became a smash in both the UK and the US. Billy moved to Jive records for the million selling American number one single 'Caribbean Queen (No More Love On The Run)', followed by 'Loverboy,' and 'Suddenly' double platinum, triple in Canada).

Mr. Ocean performed on the American leg of Live Aid in 1985. In 1986 he performed the songs 'When the Going Gets Tough, The Tough Get Going', the theme song to the Michael Douglas, Kathleen Turner and Danny Devito

movie 'Jewel of the Nile' with all three stars who joined him at Brixton Academy for the video.

The 'Love Zone' album, subsequently went straight to number two in the UK charts, staying in the top 40 for six months. In the US, there was a number one single with 'There'll be Sad Songs (To Make You Cry)'. More hits were to follow with the now classic 'Get Outta My Dreams; Get Into My Car', giving Billy yet another US number one hit.

Two more albums followed before Billy took an extended break to spend time with his family. He returned to the stage in 2007, with his daughter Cherie on backing vocals, for live dates in the UK, Europe, USA, Canada, Australia, New Zealand, Africa and the Caribbean.

He returned to the recording studio with new albums 'Because I Love You' (2008) and 'Here You Are' (2017). Most recently 'One World' (2020), spoke eloquently to a world in crisis amid the Covid19 pandemic.

Mr. Ocean is back on stage with UK festival appearances and headline dates across Europe and the US.

Former High Commissioner Ulric Cross's daughter Sue Woodford-Hollick OBE was also honoured at the event. Lady Sue Hollick was the founding Commissioning Editor of multicultural programmes for Channel 4. She has made a significant contribution to supporting inclusion in the UK, in broadcasting and the arts.



Lady Hollick started her career as an investigative journalist and award-winning current affairs producer for Granada Television, where she spent many years as a producer/director of the flagship series World in Action before moving to help launch Channel 4.

She was Chair of Arts Council England – London, and a member of the ACE National Council for many years. She is a former trustee and current advisor to Music for my Mind, a charity which aims to bring personalised music to dementia sufferers and their carers, and was the founding Chair of the Stuart Hall Foundation, established in memory of cultural theorist, Professor Stuart Hall. She is a Patron of the Runnymede Trust, One World Media, and the Stuart Hall Foundation and an Ambassador for Reprieve, the anti-death penalty organisation.

Lady Hollick has held many directorships in the arts and business, including serving on the boards of the Theatre Museum, Contemporary Dance Trust, Complicité Theatre Company, Tate Members, the Royal Commonwealth Society, English National Opera and Free Word. For seven years she was Chair of Index on Censorship, the international magazine for Free Speech. She is currently a trustee of the Hollick Family Foundation.

Other organisations Lady Hollick is associated with include AMREF, the African Medical Research Foundation, Africa's largest health charity, Leader's Quest and the Leaders Quest Foundation. In 1989 she co-founded, Bringing Up Baby, a day nursery group, which she successfully sold in 2019. Lady Hollick was awarded an OBE in 2011 for services to the arts.

Other prominent nationals on the day included Ansel Wong CBE, cultural activist, and Anne Fridal, Dramatic Soprano.

High Commissioner Vishnu Dhanpaul expressed his delight at such an array of talented nationals who have all excelled in their chosen fields.

COMMONWEALTH FOREIGN AFFAIRS MINISTERS MEET TO DISCUSS RESPONSES TO GLOBAL CRISES

Toreign Ministers from across the Commonwealth met 15 March 2023, for the 22nd annual Commonwealth Foreign Affairs Ministers Meeting (CFAMM). The meeting was held in person at the Commonwealth Secretariat headquarters, Marlborough House, in London.

The agenda focused on enhancing the resilience of Commonwealth countries, recognising the concurrent crises and challenges faced by many members such as climate change, the ongoing impacts of the pandemic and spiralling food and energy costs, which pose risks to peace and stability.

The meeting's agenda gave Ministers the opportunity to discuss governance structures and ways of working together to address challenges to the values and aspirations embodied in the Commonwealth Charter. Disruptions to food and energy security, the urgent threat of climate change, regional and localised conflict and high debt burdens affecting the lives of people across the Commonwealth were also discussed.

Ministers recognised that strong governance and accountability structures,

as well as other fundamental elements guaranteeing the rule of law are crucial to increasing countries' resilience and minimising the impacts of these challenges. Ministers noted ongoing work in the areas of governance, rule of law, good offices as well as debt management, with the latter being considered especially critical in the current global climate.

In addressing the broader theme of climate resilience, emphasis was placed on building on the outcomes of COP27. Ministers emphasised the importance of seeking ways of working together to unlock climate financing and to find innovative solutions to meet Nationally Determined Contributions (NDCs). Ministers recalled the Commonwealth Living Lands Charter, adopted at the 2022 Commonwealth Heads of Government Meeting (CHOGM) and looked forward to its implementation.

Intra-Commonwealth trade was identified as a crucial advantage which could further harnessed. Intra-Commonwealth exports rebounded in 2021 to reach an all-time high of US\$768 billion, up by almost \$150 billion from 2020. In 2022, these exports were estimated to have surpassed \$800 billion. Intra-Commonwealth exports were forecast to grow steadily over the next five years, surpassing US\$1 trillion by 2026.

Ministers encouraged more ambitious action to realise the full potential of the Commonwealth Advantage, to achieve \$2 trillion by 2030. Supporting countries in improving connectivity and maximising digital trade was identified as a key objective.

During the meeting Ministers also received an update on ongoing country situations in Guyana, Belize, Cyprus as well as the plight of the Rohingya in Bangladesh. They also congratulated the Secretariat on Commonwealth Day and heard of the Commonwealth Flag for Peace which was raised in

Commonwealth countries around the world on Commonwealth Day.


COMMONWEALTH DAY 2023 CELEBRATIONS

At their Heads of Government Meeting in 2018, Commonwealth Leaders decided that he would succeed Her Majesty Queen Elizabeth II as Head of the Commonwealth, and he acceded to the role upon her death in September 2022.

Alongside the Leaders Meeting, the Commonwealth Secretariat also hosted a gathering of the spouses, partners and the invited guests of Commonwealth Heads of Government. The event, which was hosted by Mrs. Jeannette Kagame, the First lady of Rwanda, focused on the action needed to accelerate the elimination of cervical cancer and tackle challenges impeding progress towards this goal across the Commonwealth. The spouses and partners in attendance pledged to champion advocacy and action in their respective countries.

n June 1, 2023, at the United Nations Headquarters in New York, His Excellency Dennis Francis, Permanent Representative of Trinidad and Tobago to the United Nations was elected President of the General Assembly for the 78th session. The United Nations General Assembly 78th session commenced in September 2023 and will end in September 2024.

Ambassador Francis has had a career spanning approximately forty years in the Diplomatic Service of Trinidad and Tobago. He has served as Trinidad and Tobago's High Commissioner to Jamaica, Permanent Representative to the United Nations, Geneva, as well as Permanent Representative to the World Trade Organization and to the UN Human Rights Council. He was also

Addressing Member States, Ambassador Francis said, "It is my hope to bring forward with your help and support a renewed atmosphere of conciliation, cooperation and shared commitment in addressing the many challenges and seizing every opportunity, however nascent, before the General Assembly."



DR. NATALIE JOHNSON, BREAST AND ONCOPLASTIC SURGEON BEHIND UK'S FIRST SOFTIE FOR BLACK AND BROWN WOMEN

Natalie Johnson, Trinbagonian doctor based in the UK, has made a significant impact on the lives of women of colour who have undergone mastectomies due to breast cancer. Dr. Johnson, a Breast and Oncoplastic Surgeon at The Royal Marsden, recognized the need for soft prosthetics in realistic skin tones to help these women dress more confidently. This innovation has levelled the playing field for breast cancer survivors, providing them with a range of options to feel comfortable and regain their self-esteem.

Born and raised in Port-of-Spain, Trinidad, Dr. Johnson attended Sacred Heart Girls' Roman Catholic School and Holy Name Convent before pursuing her medical degree at the University of the West Indies. In 2002, she moved to the UK to further her surgical training. Prior to her departure, Dr. Johnson discovered that Trinidad and Tobago had only one female surgeon, who was not native to the island. This realization fuelled her determination to become a surgeon and make a difference in her home country.

The softies for black and brown women, as they are called, are lightweight fabric prostheses provided to breast cancer patients after mastectomy surgery. These softies serve as padding and help survivors achieve a symmetrical look during the recovery phase. Some women use them temporarily before undergoing reconstructive surgery, while others use them permanently. Dr. Johnson and her team recognised the importance of inclusivity and patient-centered care, leading them to collaborate with Ms Sarah Adomah, a breast clinical nurse specialist, The Royal Marsden NHS Foundation Trust, Nubian Skin (a lingerie brand specializing in skin-tone products), and The Royal Marsden Cancer Charity to develop softies for women of colour.

Dr. Johnson emphasized the psychological impact of the softies, stating that every patient should receive the same care and feel that their needs are catered to. She

stressed that providing a softie that doesn't match a woman's skin tone can make her feel abnormal rather than normal. The Royal Marsden Hospital, renowned for its cancer care, supported Dr. Johnson's vision, recognizing the importance of meeting patients' specific needs.

Dr. Johnson's ultimate goal is to make these softies available to women around the world, including Trinidad and Tobago. She aims to work with governments and charitable institutions to ensure that every woman has access to this important aspect of their care.

In addition to her ground breaking work, Dr. Johnson also had a message for young girls and individuals considering career changes. Drawing from her own experience, she encouraged young girls to pursue their dreams and seize opportunities that come their way. She emphasized seeking guidance and support from others and stressed the importance of following one's passion. Dr. Johnson also urged individuals to consider career changes and challenged societal perceptions of success, emphasizing that there are numerous fulfilling and successful career paths beyond traditional professions.

Dr. Natalie Johnson's innovative work in providing soft prosthetics in realistic skin tones has transformed the lives of women of colour who have undergone mastectomies. Her patient-centered approach and dedication to inclusivity serve as an inspiration for aspiring medical professionals and individuals seeking career changes. By addressing the specific needs of patients and promoting diversity in the medical field, Dr. Johnson has made a remarkable impact on breast cancer survivors, fostering confidence, and empowering women worldwide.

LIFE-SIZE SCULPTURE UNVEILED IN TRIBUTE TO LEGENDARY THEATRE DIRECTOR DR. GERALDINE CONNOR

s. Lara Rose's life-size sculpture of Dr. Geraldine Connor was viewed in the Leeds School of Arts building and was considered to be one of the only statues of a black person on public display in the city.

The two enjoyed a close relationship, with Lara starring in Dr. Connor's Carnival Messiah production and later selecting a PhD topic based on the director's advice to explore West African Yoruba culture.

Lara said: "In my first experience of Dr. Geraldine Connor's Carnival Messiah in 2002, the seeds were sown for further inquiry into a once forbidden Yoruba culture and language.

"Following numerous conversations with Geraldine, and on her discovery of my Yoruba heritage, she said to me, 'child you need to tell your story, your Yoruba story in your art.' And now, Geraldine – Mama God - is blue to celebrate joy, like an elaborate blue ocean."

A multi-talented performer, writer, director and educator, Dr. Connor balanced her work in the performing arts industry with a Senior Lecturer role at the University of Leeds.

She sought to build cultural and educational links between the UK and Trinidadand Tobago, the country of her parents, until her death in October 2011

at the age of 59.

Dr. Alan Dunn, Reader and Ms. Lara's Director of Studies from Leeds Beckett University, said: "Lara has studied sculpture here at Leeds Beckett University since joining our postgraduate APD course, followed by two years on our Masters programme and now a sixyear PhD by Practice.

"In itself, that is a remarkable story and the manner in which her sculpture shifted during lockdown from smaller assemblages to this incredibly bold and important work, took us all by surprise."

Singer Corinne Bailey Rae, Ms. Selina McGonagle, Director of the Geraldine Connor Foundation, and Dr. Emily Zobel Marshall, LBU academic and cochair of the David Oluwale Memorial Association, were among the notable individuals present at the unveiling ceremony.

The sculpture was on display in the foyer of the Leeds School of Arts building.

ANTHONY JOSEPH WINS TS ELIOT PRIZE FOR 'LUMINOUS' POETRY COLLECTION

r. Anthony Joseph has been awarded the TS Eliot prize for his collection Sonnets for Albert, which the judges described as "luminous." This year's competition received a record-breaking 201 submissions, and Joseph takes home the £25,000 poetry prize.

The panel of judges, led by Chair Ms. Jean Sprackland, included Ms. Hannah Lowe, the winner of the 2021 Costa Book of the Year, and Mr. Roger Robinson,

the winner of the 2019 TS Eliot prize. They stated that each of the shortlisted books "spoke powerfully to us in its own distinctive voice."

Ultimately, they selected Sonnets for Albert as the winner, praising its luminous quality and its celebration of humanity's contradictions while breathing new life into the enduring form of the sonnet.

Sonnets for Albert, previously shortlisted for the Forward Prize for Best Collection,

is an autobiographical work that explores the impact of growing up with an absent father.

Aside from his accomplishments as a poet, Dr. Joseph is also a novelist, musician, and lecturer in creative writing at King's College London. He has written five poetry collections, three novels, and released eight critically acclaimed albums. His novel Kitch: A Fictional Biography of a Calypso Icon was shortlisted for the Republic of Consciousness Prize and the Royal Society of Literature's Encore Award, and longlisted for the 2019 OCM

Bocas Prize for Caribbean Literature.

Joseph was chosen as the winner from a shortlist of 10 collections. The others shortlisted included five debut poetry collections: Quiet by Victoria Adukwei Bulley, Slide by Mark Pajak, bandit country by James Conor Patterson, The Room Between Us by Denise Saul and Manorism by Yomi Sode.

he late publisher, poet and essayist John La Rose, who was born in Trinidad and Tobago has been honoured with a new street name in south Tottenham. Mr. La Rose, a former resident of Haringey, was a prominent advocate for social justice and was recognised as such by other Black authors, artists and thinkers. He played a key role in founding New Beacon Books in Stroud Green, London and later the Caribbean Artists' Movement.

The decision to rename the street as La Rose Lane was made in response to concerns raised by residents that Black Boy Lane, had racist connotations and was a source of ongoing hurt for Black people. The decision followed a thorough process of consultation with residents.

House numbers and postcodes will not be affected, and organisations including the Royal Mail will continue to recognise the old name of the street for a transitional period of one year to minimise inconvenience for residents. During the transitional period, street signs will

continue to include the former street name.

Councillor Peray Ahmet, Leader of Haringey Council, said: "I'm delighted that we're able to pay tribute to John La Rose with a new street name. John made such a

huge contribution to Black life both here in Haringey and across the UK and played an important role in gaining recognition for Black authors and artists, as well as championing inclusive education."

Mr. Renaldo La Rose, grandson of John La Rose, said: "John's family are really proud that John's life and work is to be recognised by having a road named after him. John's work was of national and international significance but much of it started here in Haringey. We hope that through having his name memorialised in this way we will bring the message of his work – the urgent need for race equality and justice – to a new audience."



of HM King Charles III and the then HM Queen Consort, several distinguished individuals were selected for key roles, one of them being the former TV presenter, Baroness Floella Benjamin DBE DL. Baroness Benjamin, known for her work in promoting human rights and diversity, was honoured with the task of carrying HM King Charles's sceptre with a dove, a symbol of spirituality, equity and mercy. Her selection represented an embrace of diversity and inclusion.



HOUSE OF COMMONS DIRECTOR GENERAL HAILS TRINBAGONIAN ROOTS

His Excellency Vishnu Dhanpaul told Mrs Marianne Cwynarski CBE, whose parents hail from the dual-island nation in the Caribbean, that her achievement 'was a source of great pride to him'.

He made the comments during his debut meeting with Sir Lindsay Hoyle, Speaker of the House of Commons, who appointed Marianne as DG, following her success in keeping the House operational during the Covid-19 pandemic.

Her efforts were also recognised in the 2021 New Year's Honours, when HRH the Prince of Wales awarded her the CBE.

Mrs Cwynarski said no-one was prouder of her success in becoming the operational leader for the House Service than her family.

'When I told my relatives over here at a party recently that I was DG, the place erupted,' she said. 'Someone from Trinidad is director general of the House of Commons?! They are incredibly proud.

'It's a lovely reminder that you can come from a very small island and have opportunities like this in your life.

'Never in my wildest dreams have I ever thought I might end up walking the corridors of power. It seems other worldly – but that is why my parents came here: for the opportunities.'

Mrs Cwynarski's parents Molly Mustapha and Joe Juanette moved from Port of Spain to Maida Vale, West London, in the late 1950s, on a scheme to attract workers from the Caribbean.

'My Dad was excited by the prospect of relocating to London in the 1950s and 60s. They absolutely loved London life,' she said.

'But I remember the sadness that they felt, particularly my Mum, about the family that they left behind.

'Even though my Dad was a graphic artist and photographer who had photos published in the Trinidad Tribune - he was sponsored by the Post Office to become a postman,' she said.

'But the job wasn't for him, and he quickly went back to the creative world of art and graphics.'

While she was born in Park Royal, Middlesex, Marianne says her upbringing was 'warm, loving and with strong links to home'.

'One of the biggest memories I had was the excitement of having a Trinidadian relative arriving with food in their suitcase,' she said.

'It was at a time when you couldn't get mangoes, tamarind balls, kurma, curry powder, super-hot pepper sauce and even coconut oil for our bodies and hair.' Marianne said her family-trips home to Trinidad were 'mind-blowing'.

'It really is like paradise, with places like Mayaro Beach, Pigeon Point and the mangroves – and such incredible wildlife, like Humming Birds, Scarlet Ibis and poisonous snakes,' she said.

'As a child, I felt like I was related to the whole island, because my Mum's family – the Mustaphas - were so well known. I can remember feeling like a celebrity everywhere I went – it was lovely.'

Now Marianne, who with husband Paul has two children, is a well-known face at the House of Commons, where she has worked for more than 20 years and oversees 3,000 people.

His Excellency Mr. Dhanpaul said: 'Your story is an incredible one and is an inspiration to many people in Trinidad and Tobago, and the diaspora who have made their homes in the UK.

"With art being such a subjective thing you will face some type of critique. But you have to remember to be true to yourself," Ms Knights said.





he United Kingdom Thalassaemia Society (UKTS), a registered organization with 45 years of operation in the UK, has played a significant role in positively impacting the lives of individuals living with thalassaemia major, an inherited and severe blood disorder. This annual competition has not only provided a platform for artists to showcase their talents but also serves as a means to inspire governments and nonprofit organizations to initiate similar campaigns aimed at raising awareness and bolstering blood stocks.

The UKTS team expressed their astonishment at the level of talent displayed in this year's submissions. They appreciated the courage exhibited by participants in creating personal and impactful art that highlights the cause. The team further expressed their enjoyment in reviewing all the entries and conveyed their desire to award prizes to every participant if possible.

Teef From Teef is a quintessentially Caribbean story about an impromptu mango-seeking adventure that takes place on a hot August day, which leads us on a young boy's journey to understanding his resilience.

The Commonwealth Short Story Prize, the world's most global literature prize, shortlisted twenty-eight exceptional stories, representing writers from 19 countries across the Commonwealth. These diverse entries address a wide range of subjects, including illness, human trafficking, decay, relationships, hope, family secrets, LGBTQ+ experiences in a challenging world, generation gaps, bittersweet friendships,



and the complexities of work life. The stories span multiple genres, including speculative and comic fiction, historical fiction, and crime.

Annually, the Commonwealth Short Story Prize recognizes the best unpublished short fiction from any of the Commonwealth's 56 Member States. Among those he has successfully reunited with their families are two former prime ministers of Trinidad and Tobago, who were profoundly moved by the reunions.

WINDRUSH FOUNDATION HONORS SAM KING MBE: CELEBRATING A PIONEER'S REMARKABLE LEGACY

19 June, 2023, the Windrush Foundation hosted a commemorative event at Lambeth Town Hall to honor the life and accomplishments of Windrush pioneer, Mr. Samuel B. King MBE. Mr. King, an ex-serviceman of the RAF during WWII, arrived in England aboard the MV Empire Windrush on 22 June, 1948. Notably, he played a pivotal role in organizing the first public celebration of Windrush Day in Brixton, London, on June 22, 1988, marking its 40th anniversary.

Mr. Samuel B. King MBE, in collaboration with Mr. Arthur Torrington CBE, established the Windrush Foundation

as a charitable organization in 1996. The Foundation's primary focus is to commemorate Windrush Day annually, which was founded by the King on 22 June, 1948.

During the event, the MR. WINDRUSH, a story that pays tribute to the life and contributions of Mr. Sam King MBE written by Ms. Angela Cobbinah and Mr. Arthur Torrington CBE was launched. Distinguished individuals such as Councillor Sarbaz Barznji, Mayor of Lambeth, Mr. John Richards, Director and Co-Founder, Windrush Foundation; and other notable personalities such as Ms. Eliora McDonald, Mr. Samuel McDonald, Mr. Elijah McDonald,

Ms. Nairobi Thompson, Ms. Almaz Teffera, Calypsonian Alexander D Great, Calypsonian Tobago Crusoe, and Mr. Arthur Torrington CBE, were among those who contributed to the programme.

Known as the Windrush generation, they played a pivotal role in shaping the cultural

The service comprised elements of worship, music, reflections, readings and prayers, touching upon relevant themes, such as the initial invitation extended to the Caribbean community, the challenges they faced upon acceptance, and the subsequent creative and significant contributions they have made to British society.

This service of thanksgiving served the purpose of honoring the enduring legacy of the Windrush generation while providing a platform for younger voices to share how they are continuing to build upon this heritage. The occasion was an opportunity to celebrate their achievements, express gratitude for their contributions, and recognize the struggles they have encountered along the way.

CARIBBEAN TAKEOVER ENGAGES VISITORS AT THE NATIONAL MARITIME MUSEUM

n 22 June, 2023, the National Maritime Museum hosted an enthralling 'Caribbean Takeover' event, organized by the Caribbean Social Forum (CSF). This event provided a unique opportunity for visitors to immerse themselves in the diverse cultures of Africa, the Caribbean and Britain.

Initiated by members of the Windrush Generation, the CSF sought to foster communication and combat isolation through educational talks, music, dance and more. Collaborating with talented artists, historians and performers, the CSF curated a day of vibrant events and celebrations that brought the museum to life.



The event was part of the special Windrush 75 celebrations at the National Maritime Museum, commemorating 75 years since the arrival of the Empire Windrush in Britain. Working together with the Caribbean Social Forum, local schools, and young people, the museum celebrated Caribbean culture and the profound legacy of the Windrush generation in the UK.

Throughout the day, visitors enjoyed a wide range of engaging activities. Led by community choir directors Ms. Ethno Vox, a multi-school choir serenaded the audience with songs connected to Windrush and the Caribbean. Workshops designed to evoke personal memories of the Caribbean, inspired by the museum's collections, allowed families to explore their heritage and make connections.

Expert talks were also featured, with writer and researcher Ms. Veronica Mckenzie shedding light on the vessels that transported people from the Caribbean to the UK between 1942-62. Mr. Carlston Walters, Chairman of the Caribbean Family History Society, guided participants through the

process of tracing their family history.

Baroness Floella Benjamin, a special guest speaker, shared her life journey and discussed her bestselling children's book, "Coming to England," which chronicled her experiences as a Windrush child arriving in England from Trinidad at the age of 10. Her book serves as a compelling testament to the triumph of courage and determination over adversity.

A visit to the Caird Library and Archive offered insight into migration from the Caribbean and details about the Empire Windrush. Attendees explored passenger lists and learned more about the historic voyage, with staff providing guidance on navigating the collections for personal research projects.

The event also provided opportunities for creative expression, including free workshops exploring the significance of poetry in discussions about racial justice, led by The World Reimagined team. Additionally, families and visitors engaged in lively Caribbean-style domino matches and immersive Calypso dance workshops, fully

experiencing the vibrant cultural traditions.

A remarkable display of new portraits paid tribute to local community heroes, reflecting the diverse and vibrant community life in the Caribbean. Ms. Clary Salandy, Artistic Director of Mahogany Carnival Arts, led the family art workshops, and Calypsonian Alexander D. Great conducted the Calypso/Soca Songwriting workshops. Artist Carl Gabriel showcased his wire-bending sculptures alongside the portraits, further highlighting the richness of Caribbean community culture.

The 'Caribbean Takeover' at the National Maritime Museum was an extraordinary celebration of Caribbean culture and the enduring impact of the Windrush generation. Through lively performances, enriching workshops, and inspiring talks, visitors were transported on a captivating journey, fostering a deeper appreciation for the shared history and cultural connections between Africa, the Caribbean, and Great Britain.

ALDWYN ROBERTS, 'LORD KITCHENER,' HONORED WITH BLUE PLAQUE

The Empire Windrush's arrival at London's Tilbury docks has become symbolic of the Commonwealth citizens' generation that settled in Britain from 1948 to 1971. Among them was Mr. Aldwyn Roberts HBM DA professionally known as Lord Kitchener, a Trinidad and Tobago musician, who introduced British audiences to Caribbean culture with his calypsos. His records gained popularity, even catching the attention of Princess Margaret, who bought a hundred copies of his recordings for her friends. Lord Kitchener married Elsie Lines in 1953 and briefly owned a nightclub in Manchester while continuing to record songs. He celebrated Manchester United and Manchester City's sporting victories in calypsos. Eventually, he returned to Trinidad in 1962 and occasionally visited England for events like the Manchester Carnival and the birth of the Notting Hill carnival.

A blue plaque was unveiled on the 75th anniversary of HMT Empire Windrush arriving in the UK, outside the house where Lord Kitchener lived in Stretford.

The unveiling, arranged by Trafford Council's Local Studies department, took place outside 48 Brooks Road, Stretford where Lord Kitchener lived from 1957-62 with his first wife, Elsie.

Speaking at the ceremony was poet Dr. Anthony Joseph, fictional biographer of Lord Kitchener and the 2022 winner of the TS Eliot poetry prize. Also speaking was poet Doretta Maynard, Dr. Ken McIntyre who spoke about Lord Kitchener's life in England and Trafford Mayor Dolores O'Sullivan.

Present at the ceremony was the first Black mayor of Trafford, Mr. Whit Stennett MBE, Councillor Tom Ross, Leader of Trafford Council, Councillor Dolores O'Sullivan; Mayor of Trafford and many Trafford community group members. A musical performance on the steel pan was provided by Mr. Ronnie 'General' Walfall.

Cllr. Ross said:

"Lord Kitchener was a great entertainer who brought life to Manchester. He brought calypso music to the UK, as well as owning nightclubs.

"He is a great example of how the Windrush generation have contributed to the UK society, so it was fitting that



we unveiled a blue plaque in his honour on the 75th anniversary of the Windrush's arrival.

"It was a privilege to be at the unveiling where we could honour a musical legend of Trafford and Trinidad."

After the unveiling, Mr. Joseph gave a talk on his research into Lord Kitchener at the Limelight centre in Old Trafford.

REMEMBERING CULTURAL LEADER VERNON SHABAKA THOMPSON (1957 -2023)

Together with Ashton Moore (aka The Mighty Tiger), Shabaka was instrumental in initiating the London Calypso Tent in partnership with the Association of British Calypsonians in 1992 (now ACASA). In 2004, he received an Arts Council Fellowship Award for a two month study of the Miami Carnival and in 2005 he became the Acting CEO of the London Notting Hill Carnival.

As the Director of London's leading African Combined Arts Centre, the Yaa Asantewaa Arts and Community Centre (London), Shabaka initiated and realised the Carnival Village project for the development and sustenance of Carnival Art in London and all its related industries, a project of which he was the initial Chief Executive.

Shabaka lectured in schools, colleges and universities, conducted Theatre in Education (TIE) workshops in primary and secondary schools across the United Kingdom, and presented papers at national and international Carnival Arts conferences. His theatre involvement included acting and directing, in various countries. Shabaka was in the process of completing a Doctor of Philosophy (PhD) in Carnival Arts Studies, having previously attained his Master of Arts in Carnival Studies, both at The University of Trinidad and Tobago (UTT).

Shabaka's ultimate vision was to contribute to the economic liberation of African people through empowerment, leadership, and the development of sustainable institutions and communities.

Shabaka is survived by his wife Angela, son Oba, mother Elise, brothers, sisters, nieces, nephews and extended family members.

rinidad and Tobago has achieved an outstanding victory at the prestigious Royal Horticultural Society 2023 Chelsea Flower Show in London, earning a well-deserved gold medal for their breathtaking presentation titled 'This Our Native Land.' The event, held annually at the Royal Hospital grounds in Chelsea, took place from 23 May to 27 May, 2023.

The win is a testament to the team's hard work and dedication, as expressed by team leader Mr. Tony Tang Kai, who emphasized the importance of perseverance and commitment in achieving success.

However, the triumph was bittersweet, marked by the sudden passing of Mr. Bernard Beckles, the team's design lead, on 3 May, 2023. The team arrived in London with more than 50 boxes of plant material on 17 May, 2023.

At the Royal Hospital in Chelsea, Mr. Valentine and Ms. McKenzie worked hand in hand with Mr. Tony Tang Kai, Ms. Melissa Lee Foon, Mr. Andre Crawford, and Ms. Simone Taylor, determined to fulfill Beckles's desire to complete a hattrick of gold medals, starting from their previous victories with 'Cazabon' in 2013 and 'Rhythms of A People' in 2019.

Mr. Tang Kai was relieved at the result and admitted to feeling emotional as he thought about his friend and colleague Mr. Beckles.

"Bernard would have been so proud of us, and especially of the younger members of

the team who worked so hard for this gold medal. This is for him." he said.

"We've been heartened by the congratulatory messages from Trinis everywhere. We're also sharing this moment with our Caribbean neighbours Barbados and Grenada, who are also taking home gold medals."

Tang Kai said the team is grateful to all those who assisted and supported this campaign to Chelsea.

"It wasn't easy getting here this year, but we are glad we persevered. We look forward to saying thanks in person to all who helped in some way, shape or form. We're happy to have done the country proud."

Up to 200,000 people visited the Chelsea Flower Show before it closed on 27 May, 2023.

Sensitive Species." Additionally, Trinidad and Tobago boast two endemic species, namely the Trinidad Piping Guan (or Pawi) and the Trinidad Mot Mot. Moreover, the islands are home to the

world's only cave-dwelling, nocturnal fruit-eating bird, the Oilbird.

The twin-island nation hosts more than 470 species of birds, including tropical

residents and winter migrants from North America, Europe, the Arctic, and South America. Notable birding areas in Trinidad include Yerette's, Caroni Bird Sanctuary, Nariva Swamp, Asa Wright Nature Centre, Pointe-a-Pierre Wild

Fowl Trust, Blanchisseuse Road, and Grande Riviere.

Participating in the Global Bird Fair was an essential opportunity for Tourism Trinidad to promote Destination Trinidad as a premier birding destination and forge connections with birding magazines, associations, and enthusiasts, strengthening collaborative efforts for bird conservation and sustainable tourism practices.

POET RONALDO MOHAMMED REPRESENTS T&T AT PARIS POETRY MARKET

he vibrant poetry scene of Trinidad and Tobago has won international recognition as writer Mr. Ronaldo Mohammed was chosen to represent the country from 7-11 June, 2023 at the 40th edition of the Poetry Market (Marché de la Poésie) in Paris, France.

Mr. Mohammed was one of ten exceptional emerging poets selected to showcase their work at the highly-anticipated literary event. The cohort stood out from 252 applications from hopefuls vying for a chance to participate in the programme. CUBING TRIUMPH: ZEKE SIRJU SETS NEW T&T
NATIONAL RECORD AT WCA COMPETITION

r. Zeke Sirju, a 13-year-old from Trinidad and Tobago, set a new national record for the 3x3x3 Rubik's Cube at the World Cube Association (WCA) competition in Stevenage, England. His average time for five solves was 14.55 seconds, with a best time of 11.48 seconds. Despite being a form four student, he ranked 67th out of 174 competitors in the second round, advancing to the semi-finals in only his second competition.

to 35 seconds. Even after the pandemic, while continuing with school, his dedication led to further improvement, achieving a remarkable 14-second solve time.

In 2022, he debuted at the WCA Stevenage Spring competition, participating in five categories. This year, Sirju surpassed his previous records in all categories and reclaimed the national record for 3x3x3. Additionally, he competed in two more categories: 3x3x3 one-handed solve and Square-1. Looking forward, he aims to consistently achieve solve times under 10 seconds, inspired by the world record of 3.13 seconds set by Mr. Max Park in July 2023.

\ he Government of the Republic of Trinidad and Tobago (GORTT), the requested United Nations Educational, Scientific and Cultural Organization (UNESCO), to proclaim August 11 World Steelpan Day annually from 2023. On July 24, 2023, the United Nations (UN) adopted a resolution for August 11 to be declared World Steelpan Day to be observed annually in the United Nation's calendar. In furtherance of the United Nations' acknowledgment that the steelpan "promotes inclusive societies, sustainable communities and the creative economy and can have a positive impact on mental health and well-being,

gender equality and youth empowerment".

The High Commission honoured this historic day, by paying tribute to our steelpan pioneers who toiled and paved the way for the accomplishment of this milestone achievement in the development of the steelpan in our Nation's history, as well as celebrate our nation's current pannists, by installing a banner on the Chancery

railing from August 10, 2023 to August 11, 2023.

Pannist, Mr. Dexter Marchan, played a medley of old time favourites, patriotic songs and classics on the steps of the High Commission.

Most notably, Mr. Sterling Betancourt MBE, renowned pan pioneer, arranger and musician played a significant role on the day. Mr. Betancourt is the last surviving member of Trinidad All Steel Percussion Orchestra (TASPO). This band gave its historic first performance at the Festival of Britain on London's South Bank exhibition grounds. The group was the first steelband to travel abroad from Trinidad and Tobago presenting the newly invented steelpan to an international audience.

High Commissioner Dhanpaul has promised that the festivities to celebrate World Steelpan Day 2024 will be much bigger and better.
