REQUEST FOR A CERTIFICATE OF NON IMPEDIMENT

Purpose

It is normally required by foreign governments who require proof that the foreigner is not married in his/her country. The Certificate of Non-impediment (a.k.a Certificate of Fact) states the marital status of a Trinidad and Tobago national under the Civil, Hindu, Muslim and Orissa Marriage Acts in Trinidad and Tobago.

Application Process

1. Submit the following documents to the High Commission in person or by email:
 - a. Completed Request for Certificate of Non Impediment Form.
 - b. Copy of a form of identification indicating your date of birth.
 - c. Fees
TT\$ 140.00 Search of Registrar & Certificate (one) fee.

Fees to be paid in the form of bank draft/money order in USD equivalent payable to REGISTRAR GENERAL. Contact the High Commission for USD value at the time of application.

USD\$2.00

Fees to be paid through 1) bank draft/money order payable to the HIGH COMMISSION OF TRINIDAD AND TOBAGO. Contact the High Commission if paying in USD currency OR 2) Western Union. Contact the High Commission for name of receiver.

- d. If the Certificate is to be mailed to you provided the following fees:

INR 275	Courier fee within India
INR 2575	Courier fee for outside India

Fees to be paid through 1) bank draft/money order payable to the HIGH COMMISSION OF TRINIDAD AND TOBAGO. Contact the High Commission if paying in USD currency OR 2) Western Union. Contact the High Commission for name of receiver.

- e. Self-addressed envelope If the Certificate is to be mailed to you.

2. The application is then sent to the Ministry of Legal Affairs in Port of Spain via the Ministry of Foreign Affairs.
3. The Mission notifies the applicant when it receives the Certificate from the Ministry of Legal Affairs.
4. Please allow three to six weeks for delivery.
