Visa Application Form Instructions

**YOU ARE ADVISED TO APPLY EARLY TO ALLOW TIME FOR PROCESSING
READ ALL INSTRUCTIONS CAREFULLY BEFORE SUBMITTING
INCOMPLETE APPLICATIONS WILL NOT BE PROCESSED**

- ◆ Fill in the visa application form in duplicate (i.e. two copies); make sure each form has **original recent passport size photographs (no less than six months) in colour with clear sight of eyes, nose, ears and chin.**
- ◆ Original signature of the applicant **must be signed** on each form. No photocopy of the signature will be allowed.
- ◆ The Visa application form can be photocopied, however only clean copies will be processed.
- ◆ Make sure handwriting is readable otherwise the application will not be processed.
- ◆ All twenty-two (22) questions **MUST** be answered.
- ◆ Any question not answered will make the application form incomplete and incomplete applications are not processed.

The following is an explanation of what is expected in each question on the form:

1. Provide Family Name or Surname as printed in your passport.
2. Provide Given Name or First Name (s) as printed in your passport.
3. Married women are to provide their Family Name (or Surname) used before they got married.
4. Provide your place and date of birth as printed in your passport
5. State what nationality you were at birth.
6. State your present nationality.
7. State whether you are married or single. Provide your passport number as printed in your passport.
8. Provide the place of issue of passport as printed in your passport and the date of issue of passport as printed in your passport in the spaces provided.
9. Provide date of expiry of passport as printed in your passport and State your occupation in the spaces provided.
10. State the name and address of the company where you currently work.
11. a. State how much money you earn each year and in what currency.
b. State the nature of your business.
12. State whether you have been deported from Trinidad and Tobago.
13. Provide the date of departure for Trinidad and Tobago.
14. Provide the address of where you will stay in Trinidad and Tobago.
15. State why you are visiting Trinidad and Tobago
16. State how long you will stay in Trinidad and Tobago
17. Provide your permanent address
18. Provide your personal contact numbers. These will be required if the Visa Unit needs to contact you for any reason. **DO NOT PROVIDE YOUR AGENT'S NUMBER. IF YOU DO YOUR APPLICATION WILL BE CONSIDERED INCOMPLETE AND WILL NOT BE PROCESSED.**
19. State whether you received a Trinidad and Tobago visa before.
Provide the Visa Number and Date of Issue of the any previous visa obtained.
20. Provide references in Trinidad and Tobago, including contact information.
21. State who will pay for your ticket and expenses during your stay in Trinidad and Tobago.
22. If traveling with your children state the name, ages and place of birth

****If you choose to utilize the services of a Third Party to apply on your behalf please also enclose the Authorisation Form in your application package. The applicant NOT A THIRD PARTY must sign the form.**

Visa Application Checklist

1	Two (2) visa application forms with ALL 22 questions completed as per instruction sheet. Both copies must have original signatures. Signatures should match.
2	Two (2) passport sized colour photographs on each application. Photos should be identical, recent (not less than six months old), good quality with a clear image of eyes, ears, chin and nose.
3	Passport valid for a period of six (6) months from the date of intended travel. If current passport is newly issued provide previous passport.
4	(1) Colour copy of the front and back page of your passport.
5	If visiting for tourist purposes provide:
	a. Original invitation letter from your tour organizer, friend or relative contact in Trinidad and Tobago stating the purpose of visit, duration of travel and source of funding for trip and expenses for travel to Trinidad and Tobago.
	b. Original job letter from current employer stating your position, salary, duration of employment and that you will rejoin the company after your visit to Trinidad and Tobago. Letter MUST have company stamp on it.
	c. If you do not know anyone in T&T, please provide the name, address and telephone contact of the hotel or guest house where you will be staying in the Reference Section.
	c. Bank Statement for the last six (6) months. Must be original document from bank.
6	If visiting for business purposes provide:
	a. Original invitation letter from your business contact in Trinidad and Tobago stating the purpose of visit, duration of travel and source of funding for trip and expenses for travel to Trinidad and Tobago. Letter must have company stamp on it if from source other than yourself.
	b. Original job letter from current employer stating your position, salary, duration of employment and that you will rejoin the company after your visit to Trinidad and Tobago. Letter MUST have company stamp on it.
	c. If you are going for business for the first time or for the first time within the last 365 days, you are advised to apply for a Single Entry visa.
	d. Bank Statement for the last six (6) months. Must be original document from bank.
	e. A certified copy of latest tax return.
	f. Enclose your business card if available.
7	If going to work in a religious capacity in Trinidad and Tobago provide: The original and two (2) copies of the letter of invitation/employment from the religious organisation in Trinidad and Tobago as well as the original and copy of the Missionary Permit from Trinidad and Tobago. (www.immigration.gov.tt)
8	If going to study in Trinidad and Tobago provide: The original and two (2) copies of the letter of acceptance from the institution in Trinidad and Tobago stipulating the course of study and duration of study. Letter must be stamped with institute's seal. *
	b. Evidence of financial support. Provide an original letter from your bank detailing account balance or an original letter from person that will be paying the tuition fees and related living expenses.*
	c. Original Student Permit from Trinidad and Tobago and two copies (www.immigration.gov.tt)
9	If taking up employment in Trinidad and Tobago please provide:
	a. Original job letter * and two (2) copies. As well as a letter and two copies from the company in Trinidad and Tobago. Letters must have the company stamp on them.
	b. Original Work Permit* and two (2) photo copies.
10	Notarized authorisation from the minor child's parents and/or legal guardians if minor child is travelling with one parent or adults who are not the minor child's parents.
11	The proposed travel itinerary. You are strongly advised not to confirm/purchase tickets until after visa application is processed.
12	Fees. Provide appropriate fees via appropriate payment method for visa application and return courier if required. If applying in a group please make combined draft for all persons in group along with courier charges if required. If an applicant has a valid Work Permit and duration is more than three (3) months, you can apply for a Multiple Entry visa
13	If unable to apply in person and you choose to use a third party, please fill in authorisation form provided.
14	Self addressed envelope for return of passport and original documents.

Visa Application Procedures

INCOMPLETE APPLICATIONS WILL NOT BE PROCESSED**

How to Submit:

1. **In person** at the High Commission between the hours of 10:00 a.m. to 12:00 p.m., Mondays to Fridays excluding Saturdays, Sundays and public holidays. ***OR***
2. **Via courier** to the High Commission attention the **Consular Unit**. If you mail your application please ensure all documents are enclosed, the application is signed and a demand draft for the visa application fee and return courier are included.

Visa Processing:

- **Will take from three (3) up to twenty one (21) days**, should no additional information and/or interview be required.
- The Visa Officer can request **additional information** if he/she requires. Should this be the case, the applicant will be contacted and if an interview is required it will be scheduled between 1:30 p.m. to 2:30 p.m. on Mondays to Fridays.
- You are advised to call the Consular Unit of the High Commission during the hours of 10:00 a.m. to 12:00 noon, Monday to Friday (except public holidays) quoting the **Tracking Number of the Ticket** you received on drop-off; or
- Send an email **at anytime** to consular@hctt.net to check on the status of your application.

Enquiries on visa procedures/applications can be made through post, email: consular@hctt.net or telephone at (91) – 4600-7500 (Mondays to Fridays between 10:00 a.m. to 12:00 Noon only excluding public holidays).

Fees are payable via bank draft in the name of '**High Commission of Trinidad and Tobago**'. For applicants applying outside of India you can send the fees via Western Union in the name of Ms. Kiva Clarke, First Secretary or Mr. Haseeb Mohammed, Second Secretary. Call or email us for the name of the payee at the High Commission.
