VISAS

INSTRUCTIONS AND GENERAL INFORMATION

Documents Required When Submitting an Application for a Visa -

- 1. Passport of Applicant
- 2. Completed Visa Application Form
- Copy of Alien Registration Card of Applicant (as applicable) or I-94 Card/Letter from the Passport
- 4. One (1) recent passport-size Photo
- 5. Recent Bank Statement
- 6. Employment Letter
- 7. Letter of Invitation from Host

Validation of Passport -

- 1. Passport MUST be Valid for the duration of the proposed stay in Trinidad and Tobago **plus** for a further period of six (6) months
- 2. Fee for Single Entry Visa US\$53.00
- 3. Fee for a Multiple Entry Visa US\$85.00
- 4. Fee for Postage:- (Subject to change without notice)
 - Applicants who reside within Florida, Alabama, Georgia, Kentucky, Louisiana, Texas, Tennessee, Mississippi, North Carolina and South Carolina **US\$25.00**
 - Applicants who reside outside of the above listed States:- US\$35.00
 - Applications from outside of the United States <u>must</u> be accompanied by a Prepaid, Self-addressed 8" x 11" Envelope (eg. FedEx; UPS)
- 5. Fees must be submitted in the form of a Money Order/Postal Order issued in the United States ONLY (NO PERSONAL OR COMPANY CHEQUES ARE ACCEPTED) and made payable to:-

Consulate General of Trinidad and Tobago -DO NOT ABBREVIATE THE NAME

Processing – The processing time for all Visas is 5-7 Business Days

Business Visitors are reminded to submit a letter from the Company/Business detailing the purpose of the visit to Trinidad and Tobago.

No assurance regarding the issuance of a Visa can be given in advance, therefore final travel arrangements should not be made until a Visa has been issued.
