## VISAS

### INSTRUCTIONS AND GENERAL INFORMATION

#### Documents Required When Submitting an Application for a Visa –

1. Passport of Applicant
2. Completed Visa Application Form
3. Copy of Alien Registration Card of Applicant (as applicable) or I-94 Card/Letter from the Passport
4. One (1) recent passport-size Photo
5. Recent Bank Statement
6. Employment Letter
7. Letter of Invitation from Host

#### Validation of Passport –

1. Passport **MUST** be Valid for the duration of the proposed stay in Trinidad and Tobago **plus** for a further period of six (6) months
2. Fee for Single Entry Visa - **US\$53.00**
3. Fee for a Multiple Entry Visa - **US\$85.00**
4. Fee for Postage – **US\$15.00**
  - Applications from outside of the United States **must** be accompanied by a Prepaid, Self-addressed 8" x 11" Envelope (eg. FedEx; UPS)
5. Fees must be submitted in the form of a Money Order/Postal Order issued in the United States **ONLY (NO PERSONAL OR COMPANY CHEQUES ARE ACCEPTED)** and made payable to:-  
**Consulate General of Trinidad and Tobago -DO NOT ABBREVIATE THE NAME**

**Processing –** The processing time for all Visas is 5-7 Business Days

**Business Visitors are reminded to submit a letter from the Company/Business detailing the purpose of the visit to Trinidad and Tobago.**

**No assurance regarding the issuance of a Visa can be given in advance, therefore final travel arrangements should not be made until a Visa has been issued.**
