## **RESTORATION OF CITIZENSHIP**

If **CITIZENSHIP** of another country was acquired after **29<sup>th</sup> July 1988**, **no application** for restoration is necessary. Application for Restoration of Citizenship may be made **only** by persons who were citizens/nationals by **birth or descent**.

### **REQUIREMENTS:**

- 1) Three (3) completed and notarized original application Form 16;
- 2) Four (4) identical passport-size colour photographs (*the photographs and declaration on the application must be sworn before and be certified by a Commissioner of Affidavits or a Notary Public*).
- 3) One (1) original Police Certificate of Character (Police Record), **not more than one year old**, from the United States of America;
- 4) One (1) original Police Certificate of Character (Police Record), **not more than one year old**, from Trinidad and Tobago;
- 5) Completed Medical Forms 40 and 40(a) (Doctor's Official Stamp to accompany signature, and telephone contact);
- 6) Original Results of Chest X-Ray, **not more than one year old**;
- 7) An **original and copy** of Trinidad and Tobago Computerized Birth Certificate (with affidavit, if necessary);
- 8) Trinidad and Tobago Passport if available, and copy of bio data page (*page with the picture*) and other relevant pages;
  - If passport is **not available**, a sworn declaration attesting to its unavailability due to loss or theft must be submitted.
- 9) Marriage Certificate(s) (**original and copy**) will be required for the verification of the change of name from one's maiden name to the married surname;
- 10) Divorce Decree(s) (**original and copy**) where necessary;
- 11) Citizenship Certificate (**original and copy**) showing the date citizenship was acquired in the country of present nationality;
- 12) Passport of country of present citizenship;
- 13) **Fee: US \$103.00 (money order only)** to be paid on submission of the application;
- 14) Additional documents as may be required.

*Mail-in applications must be accompanied by notarized copies of required originals*

\* ALL DOCUMENTS **NOT ISSUED** IN THE REPUBLIC OF TRINIDAD AND TOBAGO MUST BE APOSTILLED. (BIRTH CERTIFICATE / MARRIAGE CERTIFICATE / DIVORCE / NATURALIZATION CERTIFICATE / AFFDAVITS / NAME CHANGE DOCUMENTS).
