LOST, STOLEN OR MUTILATED PASSPORT APPLICANT CHECKLIST

PLEASE NOTE:

- All applicants who were previously issued a T&T passport must produce the passport that was last issued to them in order to process a renewal. If the most recent passport is not available or damaged; a 'NOTIFICATION FORM FOR A LOST, STOLEN OR MUTILATED TRINIDAD AND TOBAGO PASSPORT' must be completed. This is mandatory for passports that are valid or expired.
- The Lost, Stolen or Mutilated Passport Notification Form must be submitted for approval PRIOR to any submission for a new Trinidad & Tobago Machine Readable Passport.
- No fees are collected at the point in which a Lost, Stolen or Mutilated Passport Notification Form is submitted. The passport processing fee will be determined and communicated to the applicant before an application for a new Machine Readable Passport can be submitted.

Please produce two (2) coloured copies of the documents listed below when submitting the Lost/Stolen/Mutilated Notification Form

- Complete the Lost, Stolen/Mutilated Notification Form with the **RED BORDER**. Forms can be downloaded at www.foreign.gov.tt/embwashington This Form must then be Notarized
- Trinidad and Tobago Computer Generated Birth Certificate or Adoption Certificate (*If applicable*). If the applicant was not born In Trinidad and Tobago a copy of their Original Birth Certificate/ Adoption Certificate from the issuing country must be produced along with relevant copies of official translations where necessary
- Two (2) forms of photo identification (e.g. Green card, State I.D, T&T I.D, Work authorization I.D, Driver's Permit or Passport of another country)
- Police Report/ Incident Report. Note: The submission of a police report is **MANDATORY** if your passport was Lost or Stolen. If your passport is Mutilated you must write a **detailed** declaration stating how the passport became mutilated. This declaration must be **notarized**.
- Two (2) high quality passport sized color photographs, white background, no smiling, no glasses, no facial piercings, both ears visible, no hair on forehead, no shadows
- The mutilated passport (in cases of Mutilation, **no photocopy necessary**)
- A photocopy of the lost/stolen passport (*if available*)
- United States Naturalization Certificate (*if applicable*)
- Name Change Certificate or Deed Poll (*only if applicable*)
- Marriage Certificate for each Marriage (*applicable to women only*)
- Divorce Certificate(s)/ Decree Absolute for each Marriage (*applicable to women only*)
- Trinidad and Tobago Registration or Naturalization Certificate (*only if applicable*)
- Restoration Certificate (*only if applicable*)

NB: Additional documents may be required on a case by case basis from the Immigration Department.
