**DOCUMENTS REQUIRED FOR REPATRIATION OF HUMAN REMAINS FOR  
NATIONALS OF THE REPUBLIC OF TRINIDAD AND TOBAGO**

**Please submit the relevant documents to the Embassy of Trinidad and Tobago, Washington DC Immigration Department for processing. Processing usually takes between 3-5 business days. Please refer all questions regarding the process to the Immigration Attaché at the Embassy at 202-467-6490 Ext 1001.**

**HUMAN REMAINS**

1. ***Death Certificate*** for the deceased national. Death certificates must include the name of the deceased, date of death and place of death of the deceased.
2. ***Letter of non-contagious Diseases*** issued by the Health Department within the relevant district.
3. ***Permit to dispose of or transport Human Remains*** issued by the Department of Health within the relevant district.
4. ***Embalming Certificate*** from the relevant funeral home
5. ***Passport of the Deceased***
6. ***Birth Certificate of the Deceased***
7. ***Money Order for \$20.00*** made payable to the 'Embassy of The Republic of Trinidad and Tobago'
8. ***Contact Information*** for the agency or individual making the request.
9. ***Travel Itinerary*** showing when the body is being transported
10. ***ADDITIONAL REQUIREMENTS FOR HAVING DOCUMENTS MAILED TO YOU: Money Order for \$25.50*** made payable to the 'Embassy of The Republic of Trinidad and Tobago' (Only if return postage is requested for package). For persons who opt to use this service, please provide the address where the package should be mailed and to whom it should be addressed

**CREMATED REMAINS**

1. ***Death Certificate*** for the deceased national. Death certificates must include the name of the deceased, date of death and place of death of the deceased.
2. ***Certificate of Cremation.***
3. ***Letter from Funeral Home*** confirming that the urn contains only the cremated remains of the deceased.
4. ***Statement of Death*** from the funeral director
5. ***Passport of the Deceased***
6. ***Birth Certificate of the Deceased***
7. ***Money Order for \$20.00*** made payable to the 'Embassy of The Republic of Trinidad and Tobago'
8. ***Contact Information*** for the agency or individual making the request.
9. ***Travel Itinerary*** showing when the remains are being transported
10. ***ADDITIONAL REQUIREMENTS FOR HAVING DOCUMENTS MAILED TO YOU: Money Order for \$25.50*** made payable to the 'Embassy of The Republic of Trinidad and Tobago' (Only if return postage is requested for package).
