### CHILD PASSPORT APPLICATION

For Trinidad and Tobago Citizens under 16 Years Of Age

#### 1. Instructions and General Information

- Entitlement to a Trinidad and Tobago Passport is restricted to <u>Citizens</u> of Trinidad and Tobago
- ALL child applicants (minors under 16 years) must appear in person at the
  Consulate General for the Machine Readable Passport (MRP), by Appointment only
  (whether it is a First Time Issue or Renewal of a MRP). The child's <u>live photo will</u>
  be taken on the date of the scheduled appointment.

### 2. To Secure an Appointment

- Carefully read the Instructions to know your required documents
- See Embassy Document No. 6 for the application form, and either:-
  - Download the application form, print and complete **or**
  - Complete the application form online and print it.

NOTE: Completion of Section 5 of the Form has been waived

Your completed application form, together with coloured copies of the required documents should be mailed to:

- You will be notified via mail, email or telephone whether additional documents are required. Upon confirmation of your appointment date, you will be invited for an interview.
- On the day of your interview, you must bring your **original** documents and money order. The child's live photograph will be taken.

# 3. Required Documents

Original documentary evidence of Trinidad and Tobago Citizenship must be submitted.

•	If your child was born in Trinidad and Tobago, you must provide the following documents:
	Completed Application Form for Trinidad and Tobago Passport Infant/Child (for a child under 16 years).
	Child's computer generated birth certificate with PIN.
	Child's Trinidad and Tobago passport (if applicable).
	Citizenship Certificate, if the child acquired citizenship of any other country.
	Passport or Identification Card of parent who is applying for the child's passport.
	Court Order for child's change of name (if applicable).
•	Custody of Child - Separated or Divorced Parents:
	Evidence of Court Order -The parent to whom custody of the child has been awarded <u>MUST</u> produce evidence of the Court Order and any other documentary evidence as may be required
•	If the child was born OUTSIDE of Trinidad and Tobago:
	Birth Certificate.
	Foreign Passport of the child (if available).
	Proof of parent's Trinidad and Tobago Citizenship at the time of the child's birth (including
	but not limited to parent's Birth Certificate, Passports, Marriage Certificate, Divorce
	Decree).
	Naturalization or Registration Certificate, (if parent holds citizenship of another country).
	Adoption Certificate.
4. G	uidelines for Completion and Submission of Application Form
	The Application Form must be printed on Legal Size Paper (8½" x 14"), printed on both
	sides of the page and <b>in colour</b> .
	Alternatively, send a request with self-addressed <b>prepaid</b> envelope (15" x 10") for forms to
	be mailed to you, if you are unable to print the forms.
	For the passport application, the parent is deemed to be the 'Applicant' on behalf of the child.

#### • Consent/Authorisation Of Parents

□ Both Parents/Legal Guardians of the child must appear. If only one parent appears, the second parent must submit the **notarized** Consent Authorisation letter/form consenting to the passport issuance for the child. The letter/form **must be signed and notarized** within two (2) weeks of the scheduled appointment and must be accompanied by a **notarized** colored copy of the second parent's valid passport, or state issued identification. If the second parent is deceased, the Death Certificate must be submitted. (*see Consent Authorization Letter attached*).

#### 5. Replacement of Lost, Stolen or Mutilated Passport

#### **Documents to be Produced: -**

Completed Passport Application Form (see Embassy Documents #6).
The Notification Form for a Lost, Stolen or Mutilated Passport, which must be certified by
a Commissioner of Affidavits/US Notary Public or the Consul Immigration at the Consulate
General, NY (see Embassy Documents #7).
One (1) passport size photograph.
All applicable documents listed under Required Documents#3 above.
In the case of destruction by fire, a report from the Fire Authorities will be required.
Any other document(s) that may be requested at the time of interview for a replacement
passport.

If the child's passport is considered "Mutilated", it must be submitted to the Consulate General.

Note: FEES VARY FOR THE REPLACEMENT OF A LOST, STOLEN OR MUTILATED PASSPORT. THE FINAL AMOUNT WILL BE DETERMINED DURING PROCESSING.

A Machine Readable Passport reported Lost, Stolen, or Mutilated will be deactivated upon submission of the relevant forms and as a result, will no longer be valid for travel.
