INSTRUCTIONS AND GENERAL INFORMATION

Documents Required When Submitting an Application for a Visa

- 1. The applicant's passport.
- 2. Copy of entry/extension stamp indicating applicant's immigration status.
- 3. Completed Visa Application Form.
- 4. Two passport-size photos.
- 5. Bank Statement for the last 3 months prior to submission of application.
- 6. Employment Letter stating salary.
- 7. Vacation visitors letter of invitation from the host.
- 8. Business visitors a letter from Company/Business detailing the purpose of the visit.
- 9. Confirmation of hotel accommodation.
- 10. Travel Itinerary.

Validation of Passport-

- 1. Passport MUST be Valid for at least 6 months from the date of propose entry into Trinidad and Tobago.
- 2. Fee for a Single Entry Visa-\$5,100.00 Cash Only.

Processing- The processing time for all Visas is seven to fourteen Business Days.

No assurance regarding the issuance of a Visa can be given in advance. Therefore, final travel arrangements should not be made until a Visa has been issued.
